NATURE OF WORK

This is general duty police work in protecting life and property, maintaining order, preventing crimes, apprehending criminals, and enforcing laws and ordinances. Work is performed in accordance with department rules and regulations and a variety of legislated and other enactments and precedents. Work usually consists of routine patrol, preliminary investigation and traffic regulation duties that may be performed in patrol cars or on foot. Work involves an element of personal danger and employees must be able to act without direct supervision and exercise discretion and independent judgment in meeting emergencies. Assignments and general and/or special instructions are received from a superior officer who reviews work methods and results through analysis of records submitted, personal inspection and discussion. Positions at this level receive performance evaluations from designated supervisor.

MAJOR FUNCTIONS/TASKS

- *A. Perform preventive patrol
 - 1. Make vehicles stops for traffic and/or equipment violations
 - 2. Conduct residential and commercial building security checks
 - 3. Assist stalled motorists, provide directions and other information and remove items from roadways which may be a danger to traffic flow
 - 4. Prepare and submit reports on complaints, damage to property, thefts and other incidents
 - 5. Subdue and arrest individuals for commission of crimes and/or violations
 - 6. Serve warrants and subpoenas
 - 7. Patrol an assigned area of the City on foot or in a radio-equipped vehicle and respond to calls

- *B. Perform investigative duties
 - 1. Investigate traffic accidents and complaints involving crimes and/or violations
 - 2. Execute search warrants
 - 3. Conduct preliminary investigations, gather and label evidence, interview victims and/or witnesses and write investigative report
 - 4. Testify in court

- *C. Perform service related functions
 - 1. Respond to medical emergencies
 - 2. Direct vehicle and pedestrian traffic for events (parades, fairs, sporting events, general congestion etc.)
 - 3. Respond to parking complaints and enforce parking regulations
 - 4. Provide escort service when appropriate
 - 5. Maintain crowd control at fire scenes, parades, fairs, riots, and other public disorders

6. Provide first line response to fire or similar disasters to protect the public and facilitate disaster relief efforts
 7. Walk through businesses and neighborhoods to be visible and help prevent crime
 8. Meet with citizens and/or groups to resolve or reduce community crime and safety issues
- D. Perform special assignments
1. Work in junior and senior high schools as liaison officers
 2. Train and supervise new officers
 3. Provide crime prevention training/seminars to businesses, schools, and neighborhood groups
 4. Conduct investigations under the direction of the Narcotic and Detective Divisions
 5. Interact with other law enforcement agencies, criminal justice system agencies and social/community agencies

*ESSENTIAL FUNCTIONS

MINIMUM QUALIFICATIONS

Education and Experience

(standards are determined by the Minnesota Peace Officers Standards and Training (MN P.O.S.T.) Board)

Must be licensed or eligible for Minnesota Peace Officer's license prior to the effective date of appointment

Special Requirements

Must be free from any physical or emotional/mental conditions which might adversely affect the individual's performance of the duties of police officer.

Must be a citizen of the United States and possess and be able to maintain a valid Minnesota driver's license or in the case of residency therein, a valid driver's license from a contiguous state; or eligibility to obtain either of the above.

THIS POSITION IS COVERED UNDER THE RESPIRATORY PROTECTION PROGRAM

Employees currently in the position or individuals hired for this position must be able to meet medical qualifications for the use of a respirator.

KNOWLEDGE, ABILITIES, AND SKILLS

Knowledge of modern police methods and procedures

Knowledge of the limits on the use of force, including deadly force

Knowledge of state laws and City ordinances

Knowledge of the geography and demographics of the City to include economic and social characteristics and the location of important buildings

Ability to understand and carry out effectively oral and written instructions

Ability to prepare accurate, clear and concise reports

Ability to deal courteously and effectively with the general public

Ability to react quickly and calmly in emergencies

Ability to learn and use problem solving techniques

Ability to maintain composure

Ability to testify accurately and completely in court

Ability to work effectively with people of diverse cultural, economic and ethnic backgrounds

Skill in listening and problem solving

Skill in the use of first aid and cardiopulmonary resuscitation

Skill in the use of firearms and law enforcement related equipment

IN COMPLIANCE WITH THE AMERICANS WITH DISABILITIES ACT THE FOLLOWING REPRESENTS
THE PHYSICAL AND ENVIRONMENTAL DEMANDS

This position requires a majority of time spent either walking or sitting with some standing and lifting.

Weights of objects to be lifted, carried or pushed/pulled will range from ten (10) to over one hundred (100) pounds.

Climbing of stairs is often required as well as movements such as balancing, stooping, kneeling, crouching, crawling, twisting, bending, reaching, handling, fingering and feeling.

Repetitive movements of both the hands and feet are often required.

Excellent sensory skills are important (sight, hearing and speech) as well as the ability to operate a motor vehicle.

Majority of the work is performed outside with exposure to dust, fumes, noise, heat, cold, heights, glare, body fluids and physical confrontations.
